As Government has announced wearing of facial mask has been made mandatory in public place in current pandemic disaster situation to everybody vide order no. 753/XVII-ISS/2M-22/2020 dated 02.01.2022 as it is very dangerous for our society at this stage. However the above persons violated the said rules and norms which has been duty promulgated by Government of West Bengal. Considering the present situation of West Bengal as well as Whole India. I warned them to wear Mask and follow the protocol of COVID-19 & Govt. order but they did not pay heed to my words and did not comply my lawful instructions and kept on roaming within the area without wearing Mask. As such, I arrested them under the provision govt order after observing all sort of rules.
