With due respect, I Sri Nilkanta Das, son of
Sri Bidhu Das, resident of Dakshin Ektiyashal, Siliguri
Municipal Corporation, Siliguri, District - Jalpaiguri,
P.O. Seroke Road, P.S. Bhaktinagar do hereby inform
you the following facts, that on 03/01/2022 at
about 3:00 pm when I returned from work, I
got indulged in a verbal fight with my brother
namely Sushanto Das who currently resides with
me.

Due to this verbal fight my brother got instigated
and started to push me and then went on to
hit me with a iron bucket kept beside him. He
gave several blows at my head by which I received
cuts on my head and even got six stitches. After
that he went on to beat my wife and pushed her
by which she got bruises on her face. After this
he didn't stop and attacked my 14 year old
daughter when she went to stop him. In this
act even she received some injuries. This is not
the first time that my brother got violent and started
to fight with me, but previously the fights were not

I, therefore request you to kindly look into the matter and provide me with legal remedies so that the matter doesn't go into a bad situation.
