With due respect I SI Biswajit Biswas of Ashighar OP under Bhaktinagar Police station, SPC do here by lodge a written complainant against nine (09) accused persons namely (1) Pratul Ch Das (37) S/O Late Premananda Das of Purba Fakdaibari PS Bhaktinagar Dist. Jalpaiguri (2) Kala Roy Barman (46) S/O Late Monmohan Barman of do. (3) Gobinda Adhikary (36) S/O Late Anil Adhikary Ranjit More Purba Fakdaibari PS Bhaktinagar Dist. Jalpaiguri (4) Raju Sarkar (32) S/O Brindaban Sarkar of Fakdaibari near Dhakeshwari Kali Mandir PS Bhaktinagar (5) Ganesh Barman (52) S/O Late Bhabeshwar Barman of Radha Krishna Pally, Jaleshawri bazaar PS Bhaktinagar Dist. Jalpaiguri to the effect that today on 04.01.2022 at 13.55 hrs myself along with ASI Krishna Ch Singha, C/376 Shymal Choudhury and CV/909 Nityananda Choudhury while performing patrolling duty in connection with Covid -19 situation at Ashighar OP area vide Ashighar OP GDE no.84 Date 04.01.2022, at about 17.30 hrs found that the above noted persons were roaming at Baneshwar more area without wearing Mask which has been duly promulgated by Government of West Bengal due to crucial situation of corona virus though the Government has abstained them not to come out of the house without wearing mask as it is very dangerous for our society at this stage. As Government has announced wearing of facial mask has been made mandatory in public place in current pandemic disaster situation to everybody vide order no. 753/XVII-ISS/2M-22/2020 dated 02.01.2022 as it is very dangerous for our society at this stage. However the above persons violated the said rules and norms which has been duly promulgated by Government of West Bengal. Considering the present situation of West Bengal as well as Whole India. I warned them to wear Mask and follow the protocol of COVID-19 & Govt. order but they did not pay heed to my words and did not complied my lawful instructions and kept on roaming within the area without wearing Mask. As such, I with the help of force arrested them U/S 41 Cr.PC by issuing them memo of arrest and brought them to Ashighar OP and due to Covid 19 situation as per order of IC Bhaktinagar PS released them in Bail & PR bond.

I, therefore pray that a specific case under proper section of law may kindly be initiated against the above noted arrested accused persons.
