Respected Sir,

With due respect, I, **SRI SUJOY KUNDU**, Son of Shyam Sundar Kundu, Resident of Road No. 1, Beside Children Park, New Milan Pally, Siliguri, P.O. & P.S. Siliguri, Dist- Darjeeling, would like to lodge this written complaint to the effect that I am a blind person and I have been carrying on a business of Vegetable Shop under the name and style as Joy Guru Vandar on wholesale basis and out of the small earning from the said business, I have been maintaining myself somehow. During my said business, I have facing several problems to run my said business properly and taking advantage of my said situation, I have cheated several occasion. During that period, one person namely **JAY SAHA**, Son of Nitai Saha of 113, Dakghara High School, Sitaikuchi came to me and induced me that he needs a job as he is completely jobless and considering my said situation, I asked him to work with me in order to look after my said business properly to which, he has also agreed to work with me in my said business and since then, he has been working with me and during our continuation of the said business with the said person, said Jay Saha approached me that he has a good connection a broker who has been dealing a business of selling and purchasing the second hand four vehicle and also induced me to purchase one second hand vehicle from him in order to run our said business properly and believing his said version, I agreed to purchase one vehicle and he took a sum of Rs. 10,000/- as an advance money to purchase one swift vehicle but later, I came to learn that the said swift vehicle was met with an accident and by misleading the said fact, he tried to sold out the said vehicle in my favour but thereafter, I refused to purchase the said vehicle. Thereafter, said Jay Saha again induced me to purchase another vehicle Etrigra which was in good condition and also asked me to pay the Tax Payment and Instalment amounts to him to which, I have paid to him for the amount of Rs. 37,187 only for Tax and Rs. 2,860/- only for Installment amount and assured me that he will handover the said vehicle on 29.12.2021 after receiving the balance

consideration amount. On 29.12.2021, said Jay Saha accompanied with said broker namely Bikash Barman came to me and asked me to paid the balance consideration amount to them and believing their version, I have paid a sum of Rs. 1,30,000/- only to them through cheque and after receiving the said cheque from me, they taken out the said money from bank and they have also assured me that they will produce the said vehicle before me after some time, but immediately after receiving the said amount, I found that the mobile phone of Jay Saha switched off and since then, they did not make any contact with me and the said vehicle did not handover to me till now and it is my strong apprehension that taking advantage of my blindness, said Jay Saha in conspiracy with said broker Bikash Barman induced me to pay a huge amount to them and thereby, taken near about Rs. 3,00,000/- only from me on the false plea to provide me a vehicle in my favour and thereby, the cheated and deceived me and misappropriated my hardest money for their wrongful and illegal gain.

I, therefore, request you to kindly investigate into the matter and please take necessary legal steps against said Jay Saha and Bikash Barman in accordance with law and obliged thereby.
