I, Smt, Puspa Singha wife of Swadesh Singha resident of Nemaru Jote, P.O.:- Gossainpur, P.S.:- Bagdogra, Dist.:- Darjeeling, 734014, wish to here by inform you that (1) Krishna Kanta Roy son of late Upendra Nath Roy, (2) Neharu Roy son of late Upendra Nath Roy, (3) Kalyan Roy son of Neharu Roy, (4) Narayan Roy son of late Kusharu Mohan Roy, (8) Madhu Roy son of late Kusharu Mohan Roy all are resident of , Nemaru Jote, P.O.:- Gossainpur, P.S.:- Bagdogra, Dist.:- Darjeeling, 734014, has filed on Civil Suit being no 171 of 2021 in respect of the below schedule land which is still pending and the next date has been fixed on 21/04/2022.

That in spite pendency of the said Civil Suit now said Sri, Krishna Kanta Roy along with his anti-social ecosite are trying to carry some construction work in the below schedule land. My husband and his brother and the above said persons are claiming the below schedule land and to that effect the said Civil Suit is pending before the Ld. Civil Judge Junior Division at Siliguri and the Ld. Court neither passed any judgement nor passed any order with regard to any construction work in the below schedule land.

On 30/12/2021 at around 03.30pm the above said persons again tried to encroach upon the below schedule land and thereby tried to construct wall and after coming to learn about the matter when I along with my family members reached there and tried to talk with them they abused us used filthy languages and suddenly they attacked upon us kicked and assaulted my son Subham Singha they also caught me and toughed me in illegal manner even they suddenly caught my son's neck and pressed his neck with an intention to kill him somehow my other family members saved us.

I would therefore request you to take necessary step against those persons. I fear that such illegal activities will be made at any time by the said person.
