I, Arjun Singh (56) S/o Lt. Basit Singh, resident of Shashtri Marg, Santoshi Nagar, ward No. 5 SMC, P.O-Siliguri Bazar, P.S-Siliguri, Distt-Darjeeling, beg to inform you that my son namely, Jaikishan Singh (22), was in long-term relationship, with a girl namely, Kavita Mahato D/o Sri Bharat Mahato of Santoshi Nagar (Shashtri Marg), ward No. 5 SMC, P.O-Siliguri Bazar, P.S-Siliguri, Distt-Darjeeling, and my said son, intended to marry her, but the said girl had affairs with other boys also, and her habit was to take money from those boys. The said Kavita Mahato also demanding huge amount of money from my said son, and when my son objected on her extra-love affairs with others and refused to give any money, then said girl broken-up all relationship with my son, Jaikishan Singh.

From longtime, said (1) Kavita Mahato D/o Sri Bharat Mahato & her mother namely, (2) Smt. Maya Mahato w/o Sri Bharat Mahato, were torturing my said son, mentally, and on dt. 03.01.2022 at about 04.00 pm, my said son Jaikishan Singh, returned home at Santoshi Nagar and after a while started vomiting and when his health conditions became bad, I immediately shifted him to Siliguri Distt Hospital and seeing his serious condition, he was referred to North Bengal Medical College & Hospital, and admitted there, and on dt. 04.01.2022, morning, he was expired at North Bengal Medical College & Hospital, and we came to know that he had taken some poisonous substance, due to the mental torture from said girl (1) Kavita Mahato & her mother, Smt. Maya Mahato.

So, take necessary action against said (1) Kavita Mahato & her mother, Smt. Maya Mahato, who abets the commission of suicide of my son, Jaikishan Singh.
