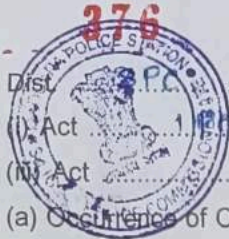

I, SI Subir Chowdhury of Matigara PS SPC to the effect that on 06.01.2022 while performing SPL Mobile duty under Matigara PS area found five persons namely (i) Santu Roy, S/O Dhajen Ch.
