I, SI Arindam Banerjee of Matigara PS SPC to the effect that on 06.01.2022 while performing SPL Mobile duty under Matigara PS area found four persons namely (i) Samrat Sarkar (18), S/O Dipak Sarkar of Gas Godwon, Darjeeling More, PS - MTG, Dist - DJG, (ii) Prasenjit Roy (24), S/O Sunil Roy of Paticolony, PS - MTG, Dist - DJG, (iii) Gour Das (32), S/O Madhab Das of Hyderpara, Kalibari Road, PS - BKN, Dist - JPG, (iv) Raju Majhi (27), S/O Parsuram Majhi of Bhanu Nagar, PS - BKN, Dist - JPG were loitering near Shivmandir Bazar under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt.
