Sir,

In producing herewith the arrested accused persons namely (1) Manatos Paul (26), s/o - Alin Krishna Paul, of Kachrapara, P.S - Bichpur, Dist - North 24 Pargana, (2) Vicky Kumar Mahto (19), S/O - Amarnath Mahto, of Belown Ghangi, P.O-Balia Belown Pialpur Dhang, Katihar, Bihar (3) Pintu Ganguly (34), s/o - Sambhu Nath Ganguly of Thiknikata, P.O-Sushruta Nagar, P.S-Matigara, Dist.-Darjeeling (4) Sribas Pal (35), s/o - Anil Krishna Pal, of Kachrapara, P.S - Bichpur, Dist - North 24 Pargana, (5) Ripan Paul (43), s/o - Jiten Paul of Kawakhali, P.O-Sushruta Nagar, P.S - Matigara, Dist.-Darjeeling (6) Biswajit Roy (20), s/o - Mahabir Roy, of - Vill - Bairagipara, PO + PS - Rajganj, Dist - Jalpaiguri arrested u/s 41 Cr.PC do hereby lodge a written complaint against him.

In this regard, I beg to state that on 06/01/2022 at about 16.20 hrs. While performing special mobile duty vide GDE No: 159 DT: 06/01/2022, received information that some people are violating the order of Lockdown and roaming aimlessly at North Bengal Medical College & Hospital, Gate No - 1. Informed O/C, Matigara PS and as per his direction, I along with force had been to North Bengal Medical College & Hospital, Gate No - 1 under NBMC & Hospital OP and arrested the above noted accused person. Thereby completely violating the lockdown measures issued by Chief Secretary West Bengal vide order no. 753/XV II-ISS/2M-22/2020 DTD.02/01/2022. On seeing police, he tried to flee away but somehow, the above noted person could be apprehended. On interrogation, he disclosed his name and address as noted above. On further interrogation, he admitted that he was aware of the lockdown Order and Restrictions imposed upon the movement of human being and shops. As he has violated the Lockdown Order promulgate by the appropriate Government Authority and also the provision of Disaster Management Act, 2005, I with the help of force arrested him U/S 41 CrPC by issuing him memo of arrest.

I, therefore pray that a specific case under proper section of law may kindly be initiated against the above noted arrested accused person.
