Sir,

In reference to the subject mentioned above, I would like to inform you that the undersigned have received an information that Sacred Heart School located at Atharakhai Gram Panchayat under Matigara Block, is continuing Classes and Hostel with full strength of students, violating the COVID protocols and recent Restrictions Order imposed by the Govt. of West Bengal vide Order No. 753/XVII-ISS/2M-22/2020 dated:02.01.2022 of Chief Secretary, Govt. of West Bengal. After taking cognition of the matter, we immediately rushed to the spot with The District Inspector, Secondary Education, AI of School, SI (Siliguri-West Circle) and BMOH, Matigara BPHC, OC, Matigara PS & Matigara Block Officials to verify the authenticity of the information. After visiting the School, It is evident that the School Authority is continuing their classes which is complete violation of Restriction Order published by Government of West Bengal. We have immediately closed the School and instructed the Director of the School and School authority to send back all the students to their home and keep the school closed until further order.
