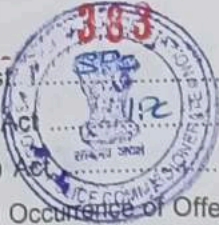

child by ~~not~~ accusing various incident.

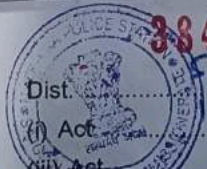
