Kundu, (Ph-8101066579), Nabanir Apartment, Raja Ram Mohan Roy Road Bye Lane (Hemanta Mukherjee Sarani), Near S.B.I A.T.M., E. V. Pally, Siliguri due to non payment.

Sir,

On 04.01.2022 at around 01.30 p.m. the representative of WBSEDCL attempted for disconnection of a service connection i.r.o. Consumer ID 412100620 in the name of Sri Swapan Kr. Kundu due to non payment but his representative physically obstructed and snatched the disconnection order paper from the representatives of WBSEDCL, namely Sri Prasanta Paul and Sri Sagar Das of the entrusted agency M/S. Barman Electricals, and also threatened that he will cause further more damage if they still attempt to disconnect the line.

On arousal of this unwanted situation, the representative of WBSEDCL called the office of undersigned and then Sri Amber Ghosh (Sr. O.E.), Sri Sudipta Moitra (Sr. TSH), Sri Biswajit Ghosh (Sr. TSH) visited the premises and tried to convince him not to obstruct the government work but he kept on behaving rudely and continued his physical obstruction but however we managed to disconnect the line.
