I, SI Ashim Kr. Das of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 06.01.22 at about 20:25 hrs while performing Evening mobile van duty at Bidhan Market, near Auto Stand and found the above noted arrested persons were moving here and there without using face mask. On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and violating the Govt order. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any disease dangerous to life during Pandemic disaster situation.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/XVII-ISS/2M-22/2020 dated 15.12.21 and order No-753/XVI-ISS/2M-22/2020 dated 02.01.22. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According I arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Parvez Alam (19) S/O Aslam Ansari (2) Sanjay Jharwar (43) S/O Subhash Jharwar (3) Karan Choudhury (18) S/O Dilip Choudhury (4) Bulon Roy (21) S/O Manglu Roy of Fulbari, near Murder More, PS- NJP, Dist- Jalpaiguri (5) Rajib Dey (22) S/O Lt Sadhan Dey (6) Rajesh Choudhury (42) S/O- Rajender Prasad Choudhury (7) Bikey Chakroborty (21) S/O Laxman Chakroborty and (8) Bappa Paul (42) S/O Lt Haripada Paul and arrange for its investigation.
