In producing herewith the 02 (Two) accused persons namely (1) Ranendra Nath Talukdar @ Runu (53) S/O Late Debendra Nath Talukdar of South Shantinagar, Binay More W/no.36 PS Bhaktinagar (2) Raju Barman @ Dhana (42) S/O Late Shibben Barman of Dabgram Nawapara, Railgate PS NJP Dist Jalpaiguri of do along with the following seized articles with seizure list;

- (1) Cash Rs. 9200 /- (Rs Nine thousand two hundred) in the following denomination.
500x7=3500/-, 200x3=600, 100x40=4000/-, 50x13=650, 20x10=200, 10x25=250 (Total Rs 9200/-)
(2) One Mobile phone (small) Black coloured, Grabo IMEI NO. 911572152977522.
(3) One register labeled as Classic Super deluxe.
(4) One black coloured ball pen.

I SI Pradip Kr Singha of Ashighar OP, under Bhaktinagar PS lodged a written complaint against the above noted accused persons and three others accused persons namely (3) Bappa Das S/O Late Binay Das of Binay More Pipe line PS Bhaktinagar Dist Jalpaiguri (4) Parimal Poddar S/O Unknown of do and (5) Lakai Dey s/o unknown of do, to the effect that today i.e 08.01.2022 at 21.20 hrs received information that a SATTA is going on inside of one tin shed of Binay More, Dakshin Shantinagar PS Bhaktinagar Dist. Jalpaiguri. Accordingly I diarized the matter vide ASG OP G.D.E. No. 197 dtd. 08.01.22 & informed the matter to O.C Ashighar OP and as per his kind direction myself along with ASI Prahllad Singha C/- 1181 Bhobesh Roy & C/ 729 Dinesh Ch Roy all are of ASG OP left for the spot to verify the veracity of information vide ASG OP G.D.E.No.198 dt- 08.01.22. On arrived at 21.40 hrs at the spot found that the above noted accused persons and others are playing SATTA with the help of mobile phone, register & Pen to each other by exchange of cash to wrongful gain and wrongful loss and on seeing the police party they try to flee away from the spot but on hot chased police party apprehended the above noted accused persons namely (1) Ranendra Nath Talukdar @ Runu (53) S/O Late Debendra Nath Talukdar of South Shantinagar, Binay More W/no.36 PS Bhaktinagar (2) Raju Barman @ Dhana (42) S/O Late Shibben Barman of Dabgram Nawapara, Railgate PS NJP Dist Jalpaiguri. On being searched at the spot (1) Cash Rs. 9200/- (2) One mobile phone (3) One register & (4) One pen are found from the possession of above accused persons. Accordingly I seized all the above noted articles in presence of two independent witnesses namely (1) Dilip Das (37) S/O - Kalicharan Das of Ghogomali PS Bhaktinagar Dist. Jalpaiguri (2) Ajay Sarkar (31), S/O - Sunil Sarkar of Niranjana Nagar PS Bhaktinagar Dist. Jalpaiguri under proper seizure list with a view to take legal action as they violated the prohibition U/S- 3/4 of W.B.G. & P.C Act.

In this circumstances it is clear that the above noted accused persons namely (1) Ranendra Nath Talukdar @ Runu (53) S/O - Late Debendra Nath Talukdar of South Shantinagar, Binay More W/no.36 PS Bhaktinagar (2) Raju Barman @ Dhana (42) S/O Late Shibben Barman of Dabgram Nawapara, Railgate PS NJP Dist Jalpaiguri violated sec - 3 / 4 of W.B G & P.C Act. Accordingly I arrested them as they are violating the above mentioned section of the Acts. On interrogation they confessed that they alongwith Bappa Das S/O Late Binay Das, Parimal Poddar & Lakai Dey all are of

Binay More Pipe line PS Bhaktinagar Dist Jalpaiguri were playing SATTA inside the tin shed at Binay more Dakshin Shantinagar by exchange of cash to wrongful gain and wrongful loss with the help of mobile phone ,register & Pen.

Hence I request to you a specific case may kindly be started against the accused persons namely (1) Ranendra Nath Talukdar @ Runu (53) S/O - Late Debendra Nath Talukdar of South Shantinagar ,Binay More W/no.36 PS Bhaktinagar (2) Raju Barman @ Dhana(42) S/O Late Shibben Barman of Dabgram Nawapara,Railgate PS NJP Dist Jalpaiguri (3) Bappa Das S/O Late Binay Das of Binay More Pipe line PS Bhaktinagar Dist Jalpaiguri (4) Parimal Poddar S/O Unknown of do and (5) Lakai Dey s/o unknown of do and to arrange for its investigation.
