Sir,

I, Sri Subrata Das, s/o Sri Kalipada Das, r/o South Bharatnagar, Debashish Colony, Near Radha Krishna Mandir, Ward No. - 24 of S.M.C., P.O. & P.S. - Siliguri, Dist - Darjeeling would like to inform you that on 05/11/2021 at about 10:30 a.m. my son Sumit Das, aged about 17 years committed suicide by pouring kerosene oil and ablazing himself in an isolated room of our house. We heard his scream when he had already caught fire and we tried to douse the fire but in the meantime he was already burnt and so we rushed him to North Bengal Medical College & Hospital from where he was shifted to Life Line Research & Cancer Institute, NH - 31, By Pass Road, Near 2nd Mile, Champasari Road, Siliguri and ultimately he was declared dead on 07/11/2021. After that post mortem of my son was conducted at North Bengal Medical College & Hospital.

We were deeply shocked over such unnatural death of my son. Before committing suicide one girl namely Priya Das, d/o Niranjan Das, aged about 18 years being our close door neighbor enticed my son since before about 3 months and there was a relation between them though my son was younger to her and a student of Class XI. Since we could know about his such relation we took up the matter with the family members of Priya Das including her father Niranjan Das, step - mother Sunati Das, brother Madhusudan Das, sister - in - law Chutki Das and her grandmother Aruna Das who are involved and conspired together against my son over such relation and mentally harassed and tortured him as we could observe from the behavior of my son before committing suicide. Even on 04/11/2021 my son had been provoked by the above named persons and was found with the said Priya Das and it is my firm belief that Priya Das and the others above named not only mentally harassed and tortured him but abetted him to commit suicide. As such inspite of all efforts we could not stop Priya Das from her such conduct. We could also collect many photographs from the Mobile Phone bearing No. - 9641359955 of my son. It is to be mentioned that Priya Das and others above named belong to an influential family and immediately after my son committed suicide they fled away from their house for several days.

As I was deeply shocked and at a loss to understand what to do and being a patient of Blood Cancer was admitted to the hospital, I could not make the complaint before this so the delay. I, therefore, would like to request you to investigate the matter and take appropriate action against the offenders Priya Das and others according to law.
