I, SI. Rakesh Debnath of Ambari Falakata OP under NJP PS beg to report that on
06.01.2022 at 16:35 hrs in course of K39 Evening mobile van duty vide Ambari OP GDE
No- 168 dated 06.01.2022 myself along with force namely (1) C/ 1180 Susen Roy and
C/256 Bibhuti Mahato had been to Sahudangi More, under Ambari Falakata OP. PS. NJP
and found the above noted persons were roaming without face mask at that area
violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly,
the above noted persons were detained. On being interrogation they disclosed their
identity as mentioned above and further they failed to give any satisfactory answer
regarding their movement in that area rather they refuse to comply with direction of
Govt. order of West Bengal vide. Memo No.753/XVII-ISS/2M-22/2020 Dtd.
02.01.2022(Lock Down) in c/w outbreak of COVID-19. Accordingly I arrested them u/s
41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of
Law may kindly be started against the above noted accused persons and arrange for its
investigation.
