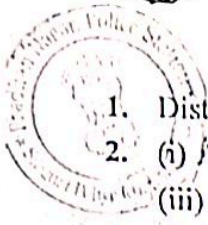

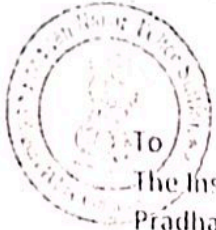

Sir,

In producing here with five arrested accused persons namely namely 1) Md. Suban (M 18) S/O- Md. Hasirul of Mallaguri, near Rail Line, w/o-46 Ps Pradhan nagar Dist-Darjeeling. 2. Pramod Singh (M 40) S/O- Lt. Shib Dayal Singh of Mahakal Pally w/o-11, PS-Siliguri Dist-Darjeeling. 3. Mukesh Kr. Singh (M 42) S/O- DO of do, 4. Manik Barman (M 36) S/O- Gopal Barman of Panitanki Gour Singh Jote PS-Khoribari Dist Darjeeling 5. Md. Suman S/O- Md. Azirul of Mallaguri PS- Pradhan nagar Dist Darjeeling arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to complain that on 04.01.2022 while performing patrolling van duty received information that some persons were loitering without gathering mask at Darjeeling More area. I along with C/207 Amrita Sarkar and C/880 Shyamal Dutta had been to Darjeeling More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486- CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19.

I, finding no other alternative, along with force apprehended them and arrested them U/S 41 Cr.P.C in between 16:30 hrs to 17:15 hrs. On interrogation, they disclosed their names and address as noted above. On further grilling, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
