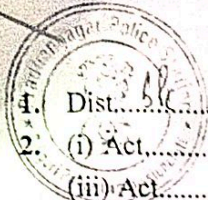

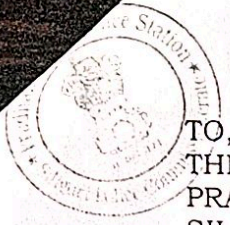

Sir,

With due respect, I am producing herewith one Accused Namely Mushanabi Ekka S/O Jwakim Ekka of Nadi Par Line ,Dagapur PS- Pradhan nagar Dist- Darjeeling (Driver of Tractor bearing reg no. WB 73 C 5717)Under arrest along with seized one Tractors bearing reg. no. WB 73 C 5717 loaded with Sand (River bed materials).

I beg to report that today i.e 08.01.2022 I was engaged in morning mobile van duty PS area, with C417 Rabindra Nath Das CV1035 Sanjib Oraon , vide PDN PS GDE No. 428 dated. 08.12.21. I was patrolling near Dagapur area under Pradhan Nagar PS and found that above noted tractor Coming from Dagapur Tea estate road I told him to stop the vehicle but driver did not pay any heed to me and tried fled way with his vehicle, Somehow we chase him and stop the above noted tractor at Church more near Pintal village more and detained the driver. On interrogation he disclosed his identity noted above. I asked to the above noted drivers to produce any document in respect of loaded river bed materials and vehicle paper, but he failed to produce supporting document regarding said vehicles .He also stated that they loaded the said sand Stone (Riverbed materials) from dagapur Tea Estate ghat Under Pradhan Nagar P.S illegally for wrongful gain ,So I arrested both of them U/S 41 Cr.P.C and seized the loaded vehicle under proper seizure list. Seized in between 08.30 hrs to 09.05 hrs

Therefore, I pray before you that a specific case under proper section of law may kindly be Initiated against the accused persons viz: Mushanabi Ekka S/O Jwakim Ekka of Nadi Per Line, Dagapur PS- Pradhan nagar Dist- Darjeeling (Driver of Tractor bearing reg no. WB 73 C 5717) and arrange for its investigation.
