Sir,

With due respect, I SI Mijanur Rahaman of Bagdogra PS, do hereby lodge this written complaint against the following arrested persons namely i) Ranjit Adhikary 26yrs s/o Utpal Adhikary of Chatura Gach PS, Chopra PO, Bhaisvita Dist, Uttar Dinajpur ii) Surajit Basak 26yrs s/o Khagen Basak of Maynaguri Bhotpatti PS, Maynaguri Dist, Jalpaiguri iii) Md Kalam 42yrs s/o Noor Mahammad of Pramadnagar PS, Bagdogra Dist, Darjeeling iv) Piantush Lakra 47yrs s/o Anjulush Lakra of Taipoo TE, PS, Bagdogra Dist, Darjeeling v) Pijush Halder 30yrs s/o Niranjan Halder of Prakash Nagar PS, Bhaktinagar Dist, Jalpaiguri vi) Ranjit Ray 19yrs s/o Niren Ray of Dhadrapara Haldibari PS, Kotwali Dist, Jalpaiguri vii) Noorshid Alam 28yrs s/o Md Mikail of Bhujiapani Kolkata road PS, Bagdogra Dist, Darjeeling viii) Tarun Das 30yrs s/o Rabi Das of Bidhannagar PS, Phansidewa Dist, Darjeeling to violate Government of West Bengal order vide order No. 753/XVII-ISS-22/2020 dated 02.01.2022.

The facts of the case in brief is that today on 10.01.2022 in course special checking duty alongwith force vide GDE No 1072 Dtd, 10.01.2022 in between 16-15 hrs to 17-25 hrs the above noted persons were roaming at Bihar more area in casual attitude also they all are did not wearing Face mask to violating the restriction measures issued by the Government of West Bengal. I repeatedly cautioned them and warned them to wear Masks but they did not listen rather showed negligent and casual attitude and their unlawful movement found likely to spread COVID -19 dieses which is dangerous to life also high rate of infectivity and multiple cases of a new COVID-19 variant "Omicron", in addition to restriction and relaxation measures as already in force. Finding no other alternative way to save people and restraint the dieses not to spared others the above mentioned persons could be apprehended. On interrogation, they all disclosed their names and address as noted above. On further asked, they all admitted that they all were aware of the order to wear facial Mask in public place. As they had violated the order of State Government of WB vide order No 753/V-ISS/2M-22/2020 Dated 15.12.2021 and earlier orders promulgated to contain the spread of Covid-19 virus. Therefore, they were arrested in between 16-15 hrs to 17-25 hrs and brought to Police Station and put in Police Custody.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.
