I, Binod Oraon, son of Lasan Oraon, R/o. Kiran Chandra Tea Estate, Kestopore Line, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, India, would like to state that on 08.01.2022 at about 3.00 P.M., when my brother namely Mahendar Oraon, S/o. Lasan Oraon, R/o. Kiran Chandra Tea Estate, Kestopore Line, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, India, was crossing the road with his by-cycle a bus bearing WB 73 B 0079 hit my brother. The accident took place near Kestopore More, P.O. Chowpukuria, P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal.

The driver of the bus was driving the bus in very rash manner and he hit my brother due to which my brother sustained serious injuries in head and body and thereafter he was taken to Bagdogra PHC, Bagdogra. I was informed about the accident by Mr. Jagmohan Munda, S/o. Late Ram Lagan Munda R/o. Kiran Chandra Tea Estate, Kestopore Line, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, India, who was present at the accidental spot. Later the Doctor of Bagdogra PHC, Bagdogra referred by brother to North Bengal Medical College & Hospital, Sushrutanagar, Matigara, District Darjeeling for better treatment, where the doctors have kept him under observation. My brother is still admitted there at ICU and is in serious condition. At the time of accident I was at Kesyopore, Chowpukuria, Bagdogra. I was late to file the FIR as I was busy for the treatment of my brother.

It is requested before you to do the needful and take strict necessary action against the driver involved in the accident so that he can be punished as per law.
