Subject: FIR

In producing herewith five (05) arrested accused persons namely (i) Md. Samaj(21), S/O- Md. Sariful of Biswas Colony, PO+PS - Matigara, Dist- Darjeeling, (ii) Md. Jagir(27), S/O- Md. Sariful of Biswas Colony, PO+PS - Matigara, Dist- Darjeeling, (iii) Krishna Tamang (30), S/O- Sarman Tamang of Gadagali, Mechinagar-01, PS- Kakarbhita, Dist- Jhapa, Nepal, A/P- C/O- Md. Sariful of Biswas Colony, PO+PS - Matigara, Dist- Darjeeling, (iv) Md. Sajad(21), S/O -Md. Rofik of Biswas Colony, PO+PS- Matigara, Dist- Darjeeling and (v) Subhankar Paul(20), S/O- Sunil Paul of Telipara PO+PS - Matigara, Dist- Darjeeling(not verified) arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 33 inch (approx) including butt from the possession of Md. Samaj which was kept concealed on his back side.
- (2) One iron made sword measuring 29 inch (approx) including wooden butt from the possession of Md. Jagir which was kept concealed on his back side.
- (3) One iron made sword measuring 20 inch (approx) including wooden butt from the possession of Subhankar Paul which was kept concealed on his back side.
- (4) One iron made 'Knife' measuring 14 inch (approx) from the possession of Md. Sajad which was kept on his right hand,
- (5) One iron made 'Kukri' measuring 16 inch (approx) from the possession of Krishna Tamang which was kept on his right hand,
- (6) Two iron made Crowbars measuring 25 inch (approx) and 31 inch (approx) in length found from the place of occurrence.

I, PSI Shékhar Adhikary, S/O- Lt. Sonatan Adhikary of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Md. Samaj, ii) Md. Jagir, iii) Krishna Tamang, iv) Md. Sajad, (v) Subhankar Paul and (vi) Md. Kalu, (vii) Prosenjit Barman, (viii) Deepak Barman and others to the effect that today on 13.01.2022 at 01.05 hrs received a sources information that 14/15 youths have assembled at Matigar Tea garden, back side of West Point School under Matigara PS with a view to commit dacoity in a house at Tumbajote. The fact was diarized in GD vide Matigara PS GDE No-1007, dated 13.01.2022. Subsequently, after sharing the information with my superiors and as per their direction, I along with PSI Newton Biswas, ASI- Tapan Das, C/986 Rajib Sarkar C/1008 Kanak Roy, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information. At about 01.25 hrs after reaching near West Point School under PS- Matigara I met my source and being pointed by the source we started walking towards back side of West Point School. At 01.50 hrs after reaching back side of West Point School, started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted five (05) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Tumbajote area.

I thereafter, seized the above noted weapons under proper seizure list and labelled duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 02.05 hrs to 02.40hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Tumbajote area. It is also revealed from them that Md. Kalu, Prosenjit Barman, Deepak Barman and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Md. Samaj(21), S/O- Md. Sariful of Biswas Colony, PO+PS - Matigara, Dist- Darjeeling, (ii) Md. Jagir(27), S/O- Md. Sariful of Biswas Colony, PO+PS - Matigara, Dist- Darjeeling, (iii) Krishna Tamang(30), S/O- Sarman Tamang of Gadagali, Mechinagar-01, PS- Kakarbhita, Dist- Jhapa, Nepal, A/P- C/O- Md. Sariful of Biswas Colony, PO+PS - Matigara, Dist- Darjeeling,(iv)Md. Sajad(21), S/O -Md. Rofik of Biswas Colony, PO+PS-Matigara, Dist- Darjeeling and (v) Subhankar Paul(20), S/O- Sunil Paul of Telipara PO+PS - Matigara, Dist- Darjeeling (not verified),(vi) Md. Kalu, (vii)Prosenjit Barman, (viii)Deepak Barman and others and others and arrange for its investigation.
