I, SI Kalipada Barman of Matigara PS SPC to the effect that on 12.01.2022 while performing SPL Mobile duty under Matigara PS area found five persons namely (i) Manoj Prasad (52), S/O Lt. Mahadev Prasad of Siliguri, PS-SLG, Dist- DJG, (ii) Lakpa Sangay Tamang (23), S/O Dalsingh Tamang of Kurseong, PS-Kurseong, Dist-DJG, (iii) Chan Ali (34), S/O Jamrul Ali of Goalgach, PS- Islampur, Dist- U/Dinapur, (iv) Jogeswar Chowdhury (56), S/O Lt. Ram Narayan Chowdhury of Sevoke Road, Ward No-10, PS-SLG, Dist- DJG, (v) Babai Dey (37), S/O Pradip Ch. Ram Narayan Chowdhury of Sevoke Road, Ward No-10, PS-SLG, Dist- DJG, (v) Babai Dey (37), S/O Pradip Ch. Dey of Ramkrishna Colony, PS-PDN, Dist-DJG proper section of law and arrange for its investigation.
