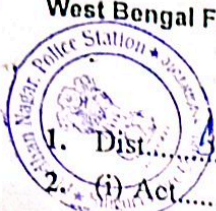

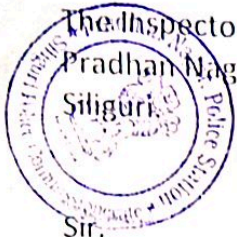

Sir,

In producing here with seven arrested accused persons namely 1) Md. Nazrul (36) S/o Lt. Md Habib OF Mallaguri, Ratanlal Busty Ward No 01 PS- pradhan Nagar, Dist-darjeeling, 2) Krishna Mistri (32) s/o Lt. Haren Mistri of vill- Belgharia, PO- Pitinagar, Ps-Ranaghat, Dist-Nadia, 3) Nurjamal Mahammad (24) s/o Md Sabul of Udalabari Subhash Pally PS-Malbazar, Dist- Jalpaiguri, 4) Baibhav Gupta (22) s/o Sashi Prashad Gupta of Champasari, jyoti Nagar, Ward no 46 PS-pradhan Nagar, Dist-Darjeeling, 5) Alta Khan (19) s/o Md Anwar of Bhaktinagar, Check Post , Ps-Bhaktinagar, Dist-Jalpaiguri, 6) Bidhan Bhattachariya (38) s/o Jay Prakash bhattachariya of Champasari, ward No 46 Ps-pradha nagar Dist-darjeeling, 7) Sachin Mahato (180 s/o Ram Mahato of Champasari Debidanga, Milan more PS-pradhan Nagar, Dist-darjeeling under arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to inform you that on 08.01.2021 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I, SI khela along with C/880 shyamal Dutta and VP 09 S Kodalia had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 15:15 hrs to 16:55 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
