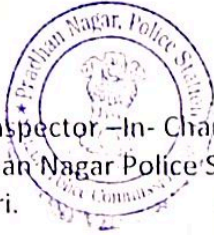

Sir,

In producing here with four arrested accused persons namely 1) Nirmal Uprety (21) s/o kamal Prasad uprety of Matigara Bazar, ps Matigar dist-Darjeeling, 2) Sailesh Kr. Singh s/o Lt Raj Mangal Singh of Durgaguri Darjeeling more ps-Pradhan Nagar Dist-Darjeeling 3) Adarsh Modi (31) s/o Pusushottam Modi of Sevoek road ward No 13 Panjabi Para PS Bhaktinagar Dist- Jalpaiguri, 4) Sourav Suman (22) s/o surendra suman of Dagapur ps- Pradhan Nagar ,Dist- Darjeeling under arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to inform you that on 08.01.2021 while performing patrolling van duty received information that some persons were loitering without wearing mask at Darjeeling More area. I, ASI Prabal Sarkar along with C/999 Mithu Chandra Roy and CV 993 Anil Das had been to Darjeeling More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41CrPC in between 15:15 hrs to 16:55 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
