Sir,

In producing herewith the following accused persons namely:- (1) Manik Barman S/O-Nikhil Barman of Botal Compani, PS-Pradhannagar, Darjeeling. 2. Assur Ali S/O-Eajaruddin of Daspara, Chopra, U/Dinajpur 3. Subash Nag S/O-Lt. Nirod Nag of South Palash, Champasari, Pradhannagar, Darjeeling. 4. Md. Sohel S/O-Rahumudden of Barsai, PS-Barsai, Katihar, Bihar. 5. Ajay Das S/O-Naba Kumar Das of Bhaktinagar, NJP, Jalpaiguri. 6. Kamallesh Bhowmick S/O-Pulin Bhowmick of Bagha jyotin Colony, Pradhannagar, Darjeeling and lodged a written complaint against them, to the effect that on 08.01.2022 in between 17:05 hrs. to 17.30 hrs. I, SI. Arindam Chatarjee along with C/963 Prabir Karmakar, C/946 Rajiv Barman, CV/217 Md. Sams Tabrej and CV/693 Ganga Ram of Junction TG, SPC was performing traffic regulation duty at Old Pradhannagar PS Gate, Ps-Pradhan Nagar, Dist- Darjeeling vide Junction Traffic Guard GDE No. 102/22 Dt- 08.01.2022 found that, they were loitering here and there without wearing mask or not taking any preventive measures to restrict the spread of Covid-19, which may results in the possibilities of spread of Pandemic Corona Virus, COVID-19. As the order has already been promulgated in order to combating the spread of COVID-19 vide order No. 753/XVII-ISS/2M-22/2020 Dated: 02.01.2022 of Chief Secretary Govt. of West Bengal regarding restriction and relaxation in terms of provision of under D.M act 2005 read with West Bengal Epidemic Disease Covid-19 Regulation-2020, which are in force till 15.01.2022. Hence, they disobey the said order of West Bengal Govt. and also violated the norms of 51(b) of D.M act.

Finding no any alternative way, I arrested them U/S-41 Cr.pc. after maintaining all the arrest formalities and brought them under Pradhan Nagar P.S custody.

I, therefore request you to kindly start a specific case U/S-188 IPC r/w section 51(b) of Disaster management Act 2005 against the above noted accused persons and arrange for proper investigation.
