Today i.e, 10.1.22 at around 11.10 AM Sabitra Saha and his sister named Bhaswati Babu and his (Inu) resident of Kolkata with others came in my home and assaulted me and my mother with first and blow, piece of bamboo, rods, etc and Sabitra Saha and Bhaswati Babu hit me in my chest with his leg. Due to such attack I was taken to hospital and my treatment was done.

Therefore, I am in great fear regarding no. of incidents happening frequently after lodging case also I request you good office to kindly set the law of the land in motion to impart us justice and prevent me and my family very from those anti social elements and miscreants.
