Sir,

With due respect I, Sri Biswajit Saha, S/o Lt. Ashit Kumar Saha of Baghajatin Colony main road, P.O & P.S. Pradhannagar, Dist. Darjeeling would like to draw your kind attention to the following effect that in the year of 1992 the aforesaid Dulal Chakraborty induced my grandfather Jaypada Poddar and another two grandfathers Dilip Kumar Poddar and kishore Poddar to purchase his homestead land along with some temporary in structure standing thereon with electric connection at bagajatin Colony under P.S- Pradhan Nagar, Dist- Darjeeling and said Dulal Chakraborty used to reside at the house of Biswanath Saha at Mallaguri, back side of Cental Plaza under P.S- Pradhannagar Dist- Darjeeling, at that time my grandfathers were agreed to the proposal of Dulal Chakraborty and delivered proper market value of the said land measuring about 7.26 katha in Plot no- 602/2 Mouza -Siliguri Pargana- Patharghata, Dist- Darjeeling and said Dulal Chakraborty executed four number of Sale Deed being nos - **1.** 6907 dated 07.09.1992 in favor of Suchitra Rani Saha (my mother), **2.** 6908 dated-07.09.1992 in favor of Dilip Kumar Poddar (now deceased), **3.** 6909 dated-07.09.1992 in favor of Jaypada Poddar (now deceased) and **4.** 6910 dated- 07.09.1992 in favor of Kishore Kumar Poddar (now deceased) transferred peaceful possession of the aforesaid land in favor of purchasers and since then I along with my mother Smt. Suchitra Rani Saha and two sisters are residing in the aforesaid land without any sort of objection from any corner, after purchase my grandfathers and my mother constructed 8 number of rooms with brick wall in the aforesaid land and we also paid the Siliguri Municipal Tax in respect of aforesaid land and room being holding no- 618/2/50 and WBSEDCL also installed electric connection in my mother's name in the aforesaid land vide Consumer Number-412121091 and Siliguri Municipal Corporation also supplied the water connection in the aforesaid land and Indian Oil Corporation also supplied gas in the aforesaid

land and house in the name of Suchitra Rani Saha but since the month of December, 2020 aforesaid persons are trying to enter into our houses and disturbing various manner to extort huge amount of money with the help of some local goons otherwise they forcibly evict us from the aforesaid land by any means. Yesterday at about 8.30 pm aforesaid Dulal Chakraborty along with his daughter Keya Bhattacharjee and Koyel Chakraborty and his son-in-law Bamkim Bhattacharjee and another 3/4 persons forcibly entered into our residence and extorted Rs. 20 Lacs and tried to ran suck our house and search aforesaid Sale Deeds by showing us knife but at that time they could not succeed because those Deeds were in the custody of my relatives in another place and said Dulal Chakraborty and his son-in-law Bamkim Bhattacharjee also tried to outrage the modesty of my wife and two unknown two persons of them tried to strangulate me at that time out of fear I requested them very shortly I will hand over those deeds / money in the hands of them then they left our house with severe threat.

In view of above you are requested to look into the matter and take appropriate step / steps against the above mentioned persons as per Law.
