Sir,

In producing here with six arrested accused persons namely 1) Mukesh Gupta (23) s/o Rampukar Gupta of Rajendra Nagar Collipara PS Pradhannagar Dist Darjeeling, 2) Debasish Karmakar (21) s/o Haru Karmakar of Patticolony Road No 02, PS Pradhannagar Dist Darjeeling, 3) Aniket Das (18) s/o Chandrika Das of South Bagajatin Colony PS Pradhannagar Dist Darjeeling, 4) Amar Kumar Ram (18) s/o Arun Ram of Gurung Busty PS Pradhannagar Dist Darjeeling, 5) Ranjit Manna (32) s/o Aswari Manna of Baleswar, PS Basta Dist Baleswar (Orissa), 6) Pandip Basu Mitra (32) s/o Lt. Aditya Kumar of Gurung Busty Pradhannagar Dist Darjeeling under arrested U/S 41 Cr.P.C and do hereby I PSI Kalyan Saha lodge a written complaint against them.

In this regard I beg to inform you that on 10.01.2022 while performing patrolling van duty received information that some persons were loitering without wearing mask at Darjeeling More area. I along with C/880 Shyamal Dutta and CP- S. Kodalia had been to Darjeeling More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 18:15 hrs to 18:45 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
