In producing here with six arrested accused persons namely 1) Md. Alluddin (27) s/o Md. Sultan of Jamai Bazar PS Pradhannagar Dist Darjeeling 2) Md. Nur Alam (40) s/o Md. Jalaluddin of Dhubri, PS Belashipara Dist Dhubri (Assam) 3) Jayanta Barman s/o Pralad Barman of Satyajit Nagar PS Pradhannagar Dist Darjeeling 4) Pramad ram (40) s/o Lt. Surendra Ram of Dhanor PS Katra Dist Majaffarpur (Bihar) A/P Dhakinakata PS Pradhannagar Dist Darjeeling 5) Bikey Seda s/o Rudal Seda of Rajib Nagar PS Pradhannagar Dist Darjeeling 6) Rejel Ali s/o Haider Ali of Deep Nagar PS Pradhannagar Dist Darjeeling under arrested U/S 41 Cr.P.C and do hereby I PSI Kalyan Saha lodge a written complaint against them.

In this regard I beg to inform you that on 11.01.2021 while performing patrolling van duty received information that some persons were loitering without wearing mask at Siliguri Junction area. I along with C/559 Raju Poddar and C/704 Ratan Rai had been to Siliguri Junction and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 19:15 hrs to 20:00 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
