Sir,

In producing here with seven arrested accused persons namely 1)Md. Juman (22) s/o Md. Chaitu of Green Park mallaguri PS-pradhan Nagar, Dist-Darjeeling, 2) Abhishek SHARMA (220 S/O Arun Sharma of Mallaguri Pokaijote, PS-Pradhan Nagar, Dist-Darjeeling, 3) Bijay Kumar Sah (24) s/o Girjanand Prasad Sah of Mallaguri, Near Sani Mandir P S-Pradhan Nagar, Dist-Darjeeling, 4) Mukesh Gupta(29) s/o Rambhajan Gupta of Satyajit Nagar Colony, PS-Pradhan Nagar, Dist-Darjeeling, 5) Sanjit Mahato (22) s/o Chhatelal Mahato of Satyajit Nagar Colony, PS-Pradhan Nagar, Dist-Darjeeling, 5) Bikash Dorjee (26) s/o Lt. Man Bahadur Dorjee of Paticolony, Road No1 PS-Pradhan Nagar, Dist-Darjeeling, 7) Raju Dey (280 s/o Mantu Dey of Rajendra Nagar, Coolie Para, PS-Pradhan Nagar, Dist-Darjeeling under arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to inform you that on 12.01.2021 while performing patrolling van duty received information that some persons were loitering without wearing mask at Champasari More area. I along with C/476 jagat Chandra Roy and C/417 Rabindra Nath Das had been to Champasari More area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 Promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 15:25 hrs to 17:55 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
