Sir,
In the undersigned beg to state that I got married with Anirban Chakraborty, S/o late Ashit Chakraborty resident of Anandamayee Colony, P.O Champasari, P.S. Pradhan Nagar, Dist. Durgaling on 06.05.2016 at Serone Kaurin.

That soon after our marriage my husband and his family member started torture upon me by both physically and mentally. And I was compelled to file some cases against my husband and in-laws. That I have filed a case for recovery of my Stricken Property vide C.R. Case No. 623/2021 in the court of Id. J.M. 1st Court at Siliguri. And the Id. Court, after hearing had issued a search warrant for the search of the house of my husband.

Yesterday i.e. on 11.01.2022 at about 4.30 P.M., the Search officer appointed by the Pradhan Nagar P.S. namely S.I. Rabin Nath Sarkar called me over telephone and asked me to accompany with them during the search procedure.

When the police was conducting search in the house of my husband and when I was at the door side, suddenly my sister-in-law namely Rupali Anarami has slapped me and kicked my minor daughter, ^{Rashmi Chakraborty} consequently my minor daughter fallen in the drain and sustain injury in her leg and chest.

Therefore, I request you to kindly take necessary action against the said Rupali Anarami, w/o Bipul Ch. Anarami, of Samar Nagar, P.O. Champasari, Near Old Auto Stand, P.S. Pradhan Nagar, Dist. Durgaling and thereby oblige me.
