Sir,

In producing here with four arrested accused persons namely 1) Kiran Rai (64) s/o Lt. Manikanta Rai of Salbari Naya Busty Ps-Pradhan Nagar, Dist-Darjeeling, 2) Pinku Barman (36) s/o Lt. Bidubhushan Barman of Patharghata Palashguri, PS-Matigara, Dist Darjeeling, 3) Jiban Debnath (50) s/o Jitendra Debnath of 45/2 Baghajatin Colony, PS-pradhan Nagar, Dist-Darjeeling, 4) Pawan Roy (28) s/o Lt. Chand Kishor Roy of Cooli Para, Near Durga Nagar, PO+PS-Pradhan Nagar, Dist-Darjeeling arrested U/S 41 Cr.P.C and do hereby lodge a written complaint against them.

In this regard I beg to inform you that on 13.01.2021 while performing patrolling van duty vide Pradhan Nagar PS GDE No-737 Dated 13.01.2022 received information that some persons were loitering without wearing mask at Siliguri Junction area. I along with C/543 Purna Rishi and C/836 Sanget Chettri had been to Silguri Junction area and found that the above noted persons were gathering and loitering without wearing mask. They violated the order No.-753/XVI-ISS/2M-22/2020 dated 15/05/2021 and Notification number 347 -01.S.S / 2M-24/2020 dated 3rd June, 2020 and Memo No 486-CS/2021 dated 24th April, 2021 promulgated by Govt. of West Bengal to combat with the spread of Covid-19. Finding no other alternative, along with force apprehended them and arrested them U/S 41C.rPC in between 17:25 hrs to 18:05 hrs. On interrogation, they disclosed their names and address as noted above. On further asking, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
