Bachar of Maheshtala, Soth 24 Parganata, (iii) Arjun Harijan (24), S/O Sankar harijan of Dasarath pally, PS-BKN, Dist-JPG, (iv) Dildar Hussain (34), S/O Lutfar Rahaman of Paharpur, Bangshihari, Dist- Dakshin Dinajpur arrested u/s 41 Cr.P.C.

I, SI Kalipada Barman of Matigara PS SPC to the effect that on 13.01.2022 while performing SPL Mobile duty under Matigara PS area found five persons namely i) Raju Sarkar (34), S/O Prafullya Sarkar of Ghogomali, PS-BKN, Dist-JPG, (ii) Saru Bachar (24), S/O Sankar Ch. Bachar of Maheshtala, Soth 24 Parganata, (iii) Arjun Harijan (24), S/O Sankar harijan of Dasarath pally, PS-BKN, Dist-JPG, (iv) Dildar Hussain (34), S/O Lutfar Rahaman of Paharpur, Bangshihari, Dist- Dakshin Dinajpur were loitering near Khaprall More under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Bachar of Maheshtala, Soth 24 Parganata, (iii) Arjun Harijan (24), S/O Sankar harijan of Dasarath pally, PS-BKN, Dist-JPG, (iv) Dildar Hussain (34), S/O Lutfar Rahaman of Paharpur, Bangshihari, Dist- Dakshin Dinajpur proper section of law and arrange for its investigation.
