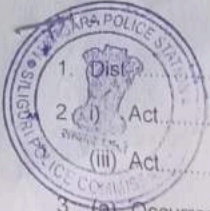

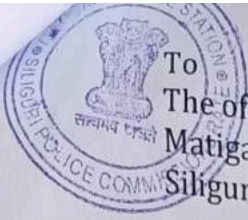

Saroj (18), S/O Md. Masud of Matigara Bazar, PS-MTG, Dist-DJG, (iv) Nikku Singh (21), S/O Sunil Singh of Matigara By Pass More, PS-MTG, Dist- DJG arrested u/s 41 Cr.P.C.

I, SI Paresh Barman of Matigara PS SPC to the effect that on 14.01.2022 while performing SPL Mobile duty under Matigara PS area found four persons namely (i) Rupak Paul (25), S/O Panchanan Paul of Telipara, PS-MTG, Dist-DJG, (ii) Pasang Tamang (22), S/O Ashok Tamang of Chotodukhuria, PS- MTG, Dist-DJG, (iii) Md. Saroj (18), S/O Md. Saroj (18), S/O Md. Masud of Matigara Bazar, PS-MTG, Dist-DJG, (iv) Nikku Singh (21), S/O Sunil Singh of Matigara By Pass More, PS-MTG, Dist- DJG proper section of law and arrange for its investigation.
