I, ASI Pradip Sarkar of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that today (07/01/22) in between 17:45 Hrs and 18: 05 Hrs in course of performing Special mobile duty I along with force went to Gate Bazar area ,PS- NJP , Jalpaiguri and found (i) Prasanta Chakraborty (59 yrs, S/o Late Biren Chakraborty of South Deshbandhu Para, PS- Siliguri, Dist- Darjeeling , (ii) Arabinda Barman @ Arjun (23yrs), s/o- Akhil Barman of Shaktigarh, Road No 2, P.S- NJP, Dist- Jalpaiguri, (iii) Bishal mallik (30yrs), s/o- Mahesh Mallik of Gate Bazar, P.S- NJP, Dist- Jalpaiguri, (iv) Sanjoy Dhar (27 yrs), s/o- Lt. Bhajan Dhar, M/o Anna Dhar of Shantipara, P.S- NJP, Dist- Jalpaiguri, (v) Sambhu Roy (19yrs), s/o- Bimal Roy of Ambikanagar, P.S- NJP, Dist- Jalpaiguri, (vi) Haradhan Sarkar (30 yrs), s/o- Lt Paritosh Sarkar of Chaturagachhr, P.S- NJP, Dist- Jalpaiguri, (vii) Madan Mohan Singh (48yrs), s/o Late Monoranjan Singh of Sukanta Pally, P.S- NJP Dist- Jalpaiguri, (viii) Ram Bharat (52 yrs), s/o Late Ganapath of Central Colony , P.S- NJP, Dist- Jalpaiguri were gathered there without any reason and found them without wearing mask and also making unnecessary gathering at Gate Bazar area. On interrogation they also stated that they were well aware of Govt. order regarding pandemic situations and wearing of facemasks was mandatory in public places in the current pandemic situation.

They all are violated the order of Govt. of West Bengal vide Memo No 753/XVII-ISS/2M-22/2029 Dtd. 02/01/2022 regarding pandemic situations.. Hence, I arrested them under proper memo of arrest in between 17:45 Hrs and 18: 05 Hrs and duly signed by them in presence of witnesses and inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
