They all are violated the order of Govt. of West Bengal vide Memo No 753/XVII-ISS/2M-22/2029 Dtd. 02/01/2022 regarding pandemic situations.. Hence, I arrested them under proper memo of arrest In between 14:05 Hrs and 14: 25 Hrs and duly signed by them in presence of witnesses and inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
