Kunderdighi, PS- NJP, Dist-Jalpaiguri and (4) Hemanta Roy (30yrs), S/o. Lt. Molin Roy of Chowdhury Vita, PO. Phutkipara, PS. Rajganj, Dist-Jalpaiguri under arrest with Memo of Arrest.

I, SI. Phup Rinchey Bhutia of Ambari Falakata OP under NJP PS beg to report that on 10.01.2022 at 16:35 hrs in course of K39 Evening mobile van duty vide Ambari OP GDE No- 343 dated 10.01.2022 myself along with force namely (1) C/ 230 Subash Das and C/975 Swarup Basak had been to Belacoba More, under Ambari Falakata OP. PS. NJP and found the above noted persons were roaming without face mask at that area violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of Govt. order of West Bengal vide. Memo No.753/XVII-ISS/2M-22/2020, Dtd. 02.01.2022(Lock Down) in c/w outbreak of COVID-19. Accordingly I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons and arrange for its investigation.
