On interrogation they also stated that they were well aware of Govt. order regarding pandemic situations and wearing of facemasks was mandatory in public places in the current pandemic situation.

They all are violated the order of Govt. of West Bengal vide Memo No 753/XVII-ISS/2M-22/2029 Dtd. 02/01/2022 regarding pandemic situations.. Hence, I arrested them under proper memo of arrest in between 16:55 Hrs and 17:45 Hrs and duly signed by them in presence of witnesses and inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
