I ASI Bhusan Ram Singh of **Bhaktinagar PS, Siliguri Police Commissionerate** do hereby lodge a written complaint against the above noted arrested persons pertaining to the effect that today on 12.01.2022 at about 18.30 hrs in course of performing evening mobile duty at Haiderpara Bazar, Sevoke Road under **Bhaktinagar PS** in order to restrict the unnecessary movement of the general public for combating the spread of COVID-19 and found the above noted arrested persons were moving freely without any valid reason and without wearing mask, thereby violating the lockdown order passed by the Chief Secretary, **Government of West Bengal vide Order No 753/XVII-ISS/2M-22/2020 dated 02.01.2022.**

Thus they violated the said order and I arrested them U/S 41 (1) (a) Cr.P.C after properly briefing them about their ground of arrest.

Hence, I would therefore request you to kindly start a specific case under section 188 IPC R/W Sec 51 (b) Disaster Management ACT 2005 above the above noted arrested persons and oblige.
