Sir,
I, Sri Gaurav Agarwal, son of Sri Jiwan Lal Agarwal, resident of Thirani Mills Compound, Gosala Road, Post Office- Siliguri Bazaar, Police Station- Siliguri, Pin- 734005, District- Darjeeling, am to write to you as follows:

1. I state that I write this letter to you for myself and for and on behalf of the members of my family i.e. (i) Sri Jiwan Lal Agarwal (my father) (ii) Smt. Rekha Agarwal (my mother) and (iii) Smt. Komal Agarwal (my wife).
2. You are already aware of the fact that we have filed a suit before the court of the Ld. Civil Judge (Junior Division) at Siliguri against Chandmoni Uttorayon Welfare Society (hereinafter referred to as "the society" for the sake of brevity) with regard to our land measuring 43.26 Katha (commonly known as Plot no. COM-17, West of Central Park, Uttorayon, Matigara) recorded in R.S.Khatian No.611 corresponding to L.R.Khatian No.811 appertaining and forming part of R.S.Plot No.477 corresponding to L.R.Plot No.676 at Mouza - Baragharia, J.L.No.82, Police Station - Matigara, District - Darjeeling and the Ld. Court has been pleased to pass an order of ad-interim injunction on 17.11.2021, which has been extended from time to time and is subsisting as on this day.

The order of injunction dated 17.11.2021 and the relevant latest information signifying its extension are enclosed herewith for your reference and perusal.
3. In spite of subsistence of the aforesaid order of injunction, today in the day time, certain officials of the society (namely Mr. Sharwan Choudry, Mr. Gopal Majumdar, Mr. Kajal Sarkar along with few others) came to our said land and have been trying to interfere with the ongoing construction in and over the said land having been undertaken by us in pursuance of the building plan sanctioned by the Executive Officer, Matigara Panchayat Samity vide order no. 466/MPS dated 05.10.2020.




