I, SI Diptajit Dhar presently posted at Khalpara TOP under your kind disposal producing here with the arrested accused persons namely 1) Sajedul haque (35/M) S/O Hossain Ali of Sutkabari, PS- Kotwali, Dist- Coochbehar, 2) Ashok Roy (49/M) S/O Gopal Roy of Santoshi Nagar, Ward No.-05, PS- Siliguri, Dist- Darjeeling, 3) Dinesh Sahani (34/M) S/O Shibji Sahani of Tikia Para, Ward No. 28, PS- Siliguri, Dist- Darjeeling, 4) Md. Sakib Alam (35/M) S/O Samser Alam of Birpur, Buspul, Dist-Supat(Bihar), 5) Gopal Jha (30/M) S/o late Debikant Jha of Ghongodia, PS- Ghangodio, Dist- Madhubani(Bihar), 6) Bipul Das (25/M) S/O Pareshh Das of Nimti Domani, PS- Kalchini, Dist- Alipurduar and 7) Md. I do hereby lodge this written complaint against the above noted arrested accused persons pertaining to the effect that on 10/01/2022 in between 13.00 hrs to 19.00 hrs in course of special mobile duty Vide Khalpara TOP GDE NO. 263 date. 10/01/2022 in an around Khalpara TOP under Siliguri Ps area at Jalpaimore in order to restrict the unnecessary movement of the general people without mask for combating the spread of COVOID 19 vide State government order No 753/XVI-ISS/2M-22/2020 dated 15/12/2021, found the above noted accused persons were moving on the main road at Jalpaimore under Khalpara TOP PS. Siliguri, Dist Darjeeling without any valid reason and taking any precautionary measures for combating the spread of COVID-19, as the order has already been promulgated in Siliguri Municipal Corporation area in order to combating the spread of COVOID 19. Thus, they violated the said order and I arrested him/them U/S-41[1][a] Cr.P.C after properly briefing them about the ground of arrest and supplied them the copy of memo arrest accordingly.

Hence, I would therefore request you to kindly start a specific case under section of Law against the above noted accused persons & obliged.
