I, Sushil Kumar Bhagat s/o Late Madan  
Bhagat, resident of Nepali Pally, Ganga Nagar  
ward No. 5 U.M.C. P.O. Siliguri Bazar, P.S. Siliguri  
Distt. Darjeeling, beg to inform you that on St.  
23.01.2021, I entered into an agreement for  
construction of my house at Ganga Nagar, ward No. 5  
P.S. Siliguri, with, Mrs. Nita Ghosh Chaki w/o Sri  
Ujjal Chaki, resident of Naranda Bazar, Chaugasani  
P.O. P.S. Bradhan Nagar, Distt. Darjeeling and for  
total assessed value of Rs. 18,72,000/- (Rupees  
eighteen lakhs seventy two thousands) only, on  
condition to pay 25% of said total assessed value  
amounting to Rs. 4,68,000/- (Four lacs sixty eight  
thousands) only, as down payment, and I paid a  
total amount of Rs. 4,53,000/- (Rupees four lacs fifty  
three thousands) only and also dismantled my  
old house at Ganga Nagar, but she did not start the  
construction.

On St. 10.01.2022 at about 11.00 am, when  
I talked with Sri Ujjal Chaki husband of Sushil  
Mrs. Nita Ghosh, over mobile phone, he denied to  
start the construction of my house, and threatened  
me for dire consequences.

Sir, I & the said (1) Smt. Nita Ghosh,  
Chaki w/o Sri Ujjal Chaki s/o Not known, induced  
me and I trusted upon them and they committed  
the breach of trust against me and cheated  
me.

So, please take necessary action against them.
