Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/XVII-ISS/2M-22/2020 Dt.15.12.2021 and order No. 753/XVII-ISS/2M-22/2020 Dt.02.01.2022. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. According, I arrested above noted persons u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
