Sir,

In producing herewith three (03) arrested accused persons namely (1) Sri Bikash Sarkar [52 yrs] S/O- Lt. Bhasan Chandra Sarkar of South Bharat Nagar, Ward No-24, PS- Siliguri, Dist- Darjeeling, (2) Sri Jayanta Sarkar [35 yrs] S/O- Jiban Kr. Sarkar of South Bharat Nagar, Ward No-24, PS- Siliguri, Dist- Darjeeling & (3) Bidyatan Sarkar [22 yrs] S/O- Bikash Sarkar of South Bharat Nagar, Ward No-24, PS- Siliguri, Dist- Darjeeling. I, SI Biswajit Sarkar of Siliguri PS/SPC do hereby lodge this complaint to the effect that, on 12.01.2022 at 13.45 hrs during my R/T mobile van duty, found the above noted 03 persons and 10/12 others started sit-in demonstration and slogan in front of Siliguri PS area violating the Govt. of West Bengal Order Nos. 753/XVI-ISS/2M-22/2020 dated 15.12.2021 and Order No. 753/XVII-ISS/2M-22/2020 dated 02.01.2022.

I requested them several times not to continue with such programme in this pandemic situation violating duly promulgated Govt. Order. But they did not pay any heed to my request and continued with their programme.

Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide Order Nos-753/XVI-ISS/2M-22/2020 dated 15.12.2021 and Order No. 753/XVII-ISS/2M-22/2020 dated 02.01.2022, in view of break-out of pandemic COVID-19 throughout the country as well as the State. Accordingly, I arrested the above noted arrested accused persons u/s- 41 Cr.P.C. others were managed to fled away from the spot.

Now, I request you for starting a case u/s- 188/269/270 IPC r/w Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested three (03) arrested accused persons and 10/12 others and arranged for proper investigation of the case.
