Kadir of Conf Depot, ward No.07, PS- Siliguri, Dist- Darjeeling were moving there without wearing masks on their face and without maintaining social distancing and also without any proper reason. Hence, they violated the order for combating the spread of COVID-19 as per order of Govt. of West Bengal vide order no-753/XVI-I.S.S/2M-22/2020 dated 15.12.2021 and 753/XVII-I.S.S/2M-22/2020 dated 02.01.2022 in view of break-out of pandemic COVID-19 throughout the State. Accordingly, the complainant arrested the above noted accused persons u/s- 41 Cr.P.C. Arrest: 05, I.O- ASI Niranjan Sarkar of Khalpara TOP under Siliguri PS, SPC. Investigation is proceeding.

I, SI Subhendu Das presently posted at Khalpara TOP under your kind disposal producing here with the arrested accused persons namely 1) Prakash Goyal (29/M) S/O Pawan Kumar Goyal of Vishant Kunj Apartment, Jyotinagar, Ward No.-41 (Ramkrishna by road) PS-Bhaktinagar, Dist- Jalpaiguri, 2) Manjur Alam (47/M) Kamrup Jaman of Fulbari, near Narayani School, PS-New Jalpaiguri, Dist- Jalpaiguri, 3) Md. Saiful (23/M) S/O Rajjak Ali of Hemtabad, near Darul Islam Madrasa, PS-Hemtabad, Dist- Uttar Dinajpur, 4) Chandan Barman (18/M) S/O Arabinda Barman of Jhankar more, Thokkar near Sarada Math, PS- Matigara, Dist- Darjeeling and 5) Md. Aftab (18/M) S/O Md. Kadir of Coal Depot, ward No.07, PS- Siliguri, Dist- Darjeeling

I do hereby lodge this written complaint against the above noted arrested accused persons pertaining to the effect that on 12/01/2022 in between 14.15 hrs to 21.00 hrs in course of special mobile duty Vide Khalpara TOP GDE NO. 322 date. 10/01/2022 in an around Khalpara TOP under Siliguri Ps area at Jalpaimore in order to restrict the unnecessary movement of the general people without mask for combating the spread of COVID-19 vide State Government order No 753/XVI-SS/2M-22/2020 dated 15/12/2021, found the above noted accused persons were moving on the main road at Jalpaimore under Khalpara TOP PS. Siliguri, Dist Darjeeling without any valid reason and taking any precautionary measures for combating the spread of COVID-19, as the order has already been promulgated in Siliguri Municipal Corporation area in order to combating the spread of COVID- 19. Thus, they violated the said order and I arrested him/them U/S-41[1][a] Cr.P.C after properly briefing them about the ground of arrest and supplied them the copy of memo arrest accordingly.

Hence, I would therefore request you to kindly start a specific case under section of Law against the above noted accused persons & obliged.
