THIS IS TO BRING TO YOUR KIND NOTICE THAT I PANKAJ AGARWAL SON OF SHRI RAMNIWAS AGARWAL RESIDENT OF MANGAL PANDEY ROAD, KHALPARA, SILIGURI HAD MADE A COMPLAINT ON DATED 20/12/2021 AGAINST SOVIT AGARWAL, SON OF ASHOK AGARWAL RESIDENT OF MANGAL VATIKA APPARTMENT, HYDERPARA, P.O. SILIGURI, P.S BHAKTINAGAR REGARDING THE FRAUDLENT AND CHEATING WITH AN ILL MOTIVE AND TOOK MY COMMERCIAL VEHICLE(MAHINDRA XYLO) WITH VEHICLE REGISTRATION NUMBER WB 76 A 6522 AND PROMISED TO PAY ME RUPEES TWO LACKS FIVE THOUSAND ONLY (RS. 2,05,000) WITHIN A SHORT PERIOD AND ALSO UNDERTO TO PAY OUT BANK OUTSTANDING AND UPCOMING EMI OF THE SAID VEHICLE FROM THE MONTH OF FEBRUARY 2020 AND THEREAFTER VARIOUS OCCASION I HAD VISITED HIS PLACE FOR REMINDING HIM ABOUT THE AMOUNT BUT ON EVERY OCCASION HE MADE A NEW EXCUSES AND RETURNED ME WITHOUT PAYING ME , I HAD ALSO LODGE COMPLAIND REGARDING THE SAME TO THE COMMISIONER OF POLICE AND ALSO TO THE OFFICER IN CHARGE KHALPARA T.O.P. (COPY ENCLOSED) I WAS VERY MUCH SURPRIZED LASTLY ON DATED 31ST DECEMBER 2021 WHEN I MET SOVIT AGARWAL NEAR PAYAL CINEMA, SEVOKE ROAD, SILIGURI I ASKED HIM ABOUT MY VEHICLE AND MONEY HE FREELY TOLD ME THAT THE VEHICLE HAS BEEN SNACHED AWAY FROM HIS DRIVER BY SOME UNKNOWN MISCREIENT A WEEK AGO FROM P.C. MITTAL BUS TERMINAL STAND AND WHEN I ASKED HIM FOR WHETHER HE HAS LODGE ANY COMPLAIN OR NOT FOR THE SAME HE TOLD ME ITS YOUR VEHICLE AND ITS YOUR LOOK OUT. HE ALSO TAKEN SIGNATURE OF MINE IN SOME BLANK PAPERS, WHICH MAY BE MISUSED BY HIM.

SO, THEREFORE I REQUEST YOU TO DO THE NEEDFUL TO TRACEOUT MY VEHICLE AND ASLO TAKE PROPER AND LEGAL ACTION AGAINST MR SOVIT AGARWAL, SON OF ASHOK AGARWAL FOR HIS ILLEGAL ACTIVITES AND FRAUD PLAY WITH ME AS PER LAW.
