Sir,

In producing herewith the one arrested accused person namely Ajit Kumar Paswan (M/21) S/O. Lt. Shibji Paswan of Santoshi Nagar near Ram-Janki Mandir, Ward No. 05, PS. Siliguri Dist. Darjeeling along with following seized articles Viz:

1) Fifteen Plastic made bottle of HIMALAYAN GOLD 60° UP COUNTRY SPIRIT. Each bottle contain 600 MI, marked MRP - 120/- totalling an amount of 1800/- rupees without any valid document.

I, ASI. Md. Jinnat Ali of Khalpara TOP under Siliguri PS, SPC do hereby lodge this complaint against the above noted accused person to the effect that on 15/01/2022 at 19.45 hrs during Evening mobile patrolling duty. Vide Khalpara TOP GDE No. 389 Dated : 15/01/2022, -I received a source information that one person namely Ajit Kumar Paswan (21) has been selling illegal liquor in his temporary road side shop at Santoshinagar near Ram Janki Mandir Machli Bazar area. There was a further complaint that due to sale of liquor the peaceful environment of the locality has been deteriorated and it is very difficult for local people to live due to antisocial activities of the drinkers, who take drinks in the shop of the accused person. After sharing the information with my officer in-charge and as per his direction myself along with C/239. Badal Barman, C/541. Santosh Roy left for Santoshinagar. Subsequently, I along with officers and force reached at Santoshi Nagar, near Ram Janki Mandir, Machli Bazar at 20.05 hrs and as showing by the source I conducted raid at the temporary shop of the accused person and on being search found the above noted articles kept in his shop without any valid permission or licence and was selling the same.

I apprehended him in presence of witness, I demanded him the papers or license, Cash memo of the said liquor, but he failed to produce any legal documents in support of possession of above noted spirit. I seized the above noted recovered I.D. liquors under proper seizure list duly packed, sealed and labelled in presence of witnesses and took their signature in the seizure list and labels and also arrested the above noted accused person U/S- 41 Cr.P.C under proper memo of arrest and observing all the formalities of arrest. The entire search and seizure process completed in between 20.15hrs to 20.45hrs on 15/01/2022 and arrested the accused at 20.50 hrs.

I therefore for pray before your honour to take charge of the seized articles and specific case start against him under proper section of law.
