In producing here with one accused person namely Khushi Sarkar (40) S/O Gurupada Sarkar Of Fakdaibari, Near Back Side Of Hatiadanga School PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure (1) 12 (Twelve) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- .

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Khushi Sarkar (40) S/O Gurupada Sarkar Of Fakdaibari, Near Back Side Of Hatiadanga School PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 16.01.2022 evening as per order of O/C Ashighar OP I along with SI Parmatha Barma, C- 877 Muina Ahamed, CV 307 Fulkumar Barman, all are of Ashigharh OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP in course of which I received information from my source that one Khushi Sarkar stored a huge numbers of bottles liquor inside his House at Fakdaibari and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar-OP and as per his kind direction wasting no time I along with my accompanied party left for Fakdaibari area to verify the veracity of information. On the way I called two local person namely (1) Dilip Das (37) S/O Kalicharan Das Ghogomali Bot Tala W/No 37 PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (28) S/O Sunil Sarkar of Niranjn Nagar W/No 36 PS Bhaktinagar Dist Jalpaiguri to accompany them to witness the search and seizure if required. On reaching at Fakdaibari area, as indicated by my source I held raid at house of Accd Namely Khushi Sarkar (40) S/O Gurupada Sarkar Of Fakdaibari, Near Back Side Of Hatiadanga School PS Bhaktinagar Dist. Jalpaiguri. But seeing us the above noted accused person try to flee away from his house, but we managed to apprehend him. I held through search in the house of above noted accused person, in course of search I recovered the above noted bottles of liqure from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 19.05 hrs and 19.25 hrs on 16.01.2022.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely Khushi Sarkar (40) S/O Gurupada Sarkar Of Fakdaibari, Near Back Side Of Hatiadanga School PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
