In producing here with the seized articles viz:-

- (1) 03(three) no's HP Domestic Gas Cylinder empty
- (2) 01(one) no HP Domestic Gas Cylinder partially loaded.
- (3) 01 (one) rubber Gas plpe approx 05 (five) ft.
- (4) 01 (one) Gas Regulator.



In producing herewith above seized articles under proper seizure list. I SI Goutam Kundu of Enforcement Branch Siliguri Police Commissionerate do hereby lodge this written complaint against the owner namely Md. Wasim S/O Md. Nasim C/O Haji Biryani, Panchyat Road, opposite Narasingha Vidyapit Ground, Shibmandir, PS- Matigara , Dist- Darjeeling Styled as "Haji Biryani" situated at Panchyat Road, opposite Narasingha Vidyapit Ground, Shibmandir, PS- Matigara , Dist- Darjeeling. Who was illegally prepare Biryani by using domestic Gas cylinder styled as "Haji Biryani" for commercial purpose without any valid documents or license to the effect that today i.e. 17.01.22 at about 13:05 hrs received an information from reliable source that one Md. Wasim S/O Md. Nasim C/O Haji Biryani, Panchyat Road, opposite Narasingha Vidyapit Ground, Shibmandir, PS- Matigara , Dist- Darjeeling has been using the domestic Gas cylinder at his kitchen where he use to prepare Biryani and sale in his stall Styled as "Haji Biryani" of Md. Wasim S/O Md. Nasim C/O Haji Biryani, situated at Panchyat Road, opposite Narasingha Vidyapit Ground, Shibmandir, PS- Matigara , Dist- Darjeeling for use commercial purpose for his wrongful gain.

Accordingly the matter informed to ACP EB SPC and as per his direction I, along with C/424 Manik Roy, L/C 1270 Deeptina Gazmer, CV/873 Kunal Biswakarma all of EB SPC with investigation kit left for Matigara PS vide EB SPC M.C.C No 04/22 Dt.17.01.2022. The matters informed to Matigara PS vide Matigara PS GDE No.1234 Dated 17/01/2022 along with K-37 van officer ASI Abdul Latif,, C/585 HitendraNath Roy, CV-783 M. Singha of Matigara PS had been to Panchyat Road, opposite Narasingha Vidyapit Ground, Shibmandir, PS- Matigara , Dist- Darjeeling to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source identification we reached at Indirapally near Railgate, Shibmandir, in the kitchen room of Haji Briyani PS- Matigara , Dist- Darjeeling and entered into kichen at mentioned address and found worker of Haji Briyani Stall are cooking Briyani by using the domestic HP Gas cylinder without any valid documents for commercial use, on demand they could not produce any valid documents in support of using the HP domestic gas cylinders for commercial use. But the owner of Haji Biryani namely Md. Wasim S/O Md. Nasim found absent from the spot. Further local enquiry it is revealed that the above noted accused person has been using the domestic HP Gas cylinder for preparing Briyani as a commercial use for his wrongful gain without any valid document. I also managed independent witness namely (1) Md Amir(18 yrs) S/O Md. Altab (2) Md. Wasim (40yrs) S/O Md. Idrish both of Haji Biryani at Panchayet Road , Opp Narasingha Vidyapith Ground, Shibmandir and (3) C/424 Manik Roy of Enforcement Branch SPC.

The owner of the "Haji Biryani" namely Md. Wasim has been using the domestic HP gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles in presence of above noted witnesses duly obtained their signature after preparing proper seizure list and label. The seizure was made in between 13"55 hrs to 14"15 hrs in presence of witnesses.

Hence, I pray before you a specific case may kindly be started under proper section of law against the accused person Md. Wasim S/O Md. Nasim C/O Haji Biryani, Panchyat Road, opposite Narasingha Vidyapit Ground, Shibmandir, PS- Matigara, Dist- Darjeeling owner of Briyani Stall Styled as "Haji Biryani" situated at Panchyat Road, opposite Narasingha Vidyapit Ground, Shibmandir, PS- Matigara , Dist- Darjeeling and arrange for its investigation.
