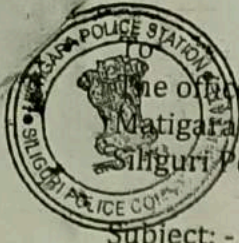

I, SI Paresh Barman of Matigara PS SPC to the effect that on 17.01.2022 while performing SPL Mobile duty under Matigara PS area found four persons namely (i) Jit Chakraborty (27), S/O Prabir Chakraborty of Deshbandhu Para, PS- SLG, Dist- DJG, (ii) Abinash Sah (18), S/O Abdesah Sah of South Ambedkar Colony, Ward No-1, PS - PDN, Dist- DJG, (iii) Surat Sah (24), S/O Sunil Sah of Balurghat, PS- Balurghat, Dist- D/Dinajpur, (iv) Sagar Paul (23), S/O Mukul Paul of Paulpara, PS - MTG, Dist- DJG were loitering near Khaprail More under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt. Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Jit Chakraborty (27), S/O Prabir Chakraborty of Deshbandhu Para, PS- SLG, Dist- DJG, (ii) Abinash Sah (18), S/O Abdesah Sah of South Ambedkar Colony, Ward No-1, PS - PDN, Dist- DJG, (iii) Surat Sah (24), S/O Sunil Sah of Balurghat, PS- Balurghat, Dist- D/Dinajpur, (iv) Sagar Paul (23), S/O Mukul Paul of Paulpara, PS - MTG, Dist- DJG proper section of law and arrange for its investigation.
